Miscellaneous Works are defined as remedial works to specifically identified 'components' or 'areas' of Association-owned property where works or measures are necessary to ensure the health and/or safety of tenants/others; or to comply with new statutory requirements. Miscellaneous works may include:

- Managing asbestos
- Designing Out Crime
- Complying with disability legislation
- Energy Conservation
- Fire Precautions
- Lead in Drinking Water
- Radon
- Control of legionella

Failure to take action in known circumstances or to assess the risk could leave the Association open to criticism or the possibility of legal action, or to render the dwelling uninhabitable or 'difficult to let.'
