Through Shared Parental Leave and Pay:

- greater flexibility for parents in childcare arrangements;
- greater choice for mothers over the timing of their return to the labour market, supporting their connection to the workforce and future career development;
- maintenance of the important contribution to the Northern Ireland economy made by working parents by keeping parents in work;
  - employer benefits arising from increased retention of staff and greater flexibility in discussing how and when parental leave is taken; and
- enhanced child welfare and better relationships between fathers and children.

Right to Request Flexible Working:

- benefits to business through improved attendance, recruitment, retention and morale; more responsive and flexible business models and higher productivity;
- benefits to employees include enabling more people to accommodate their responsibilities outside of work and hence stay in work, or re-enter the labour market; and

- benefits to society through greater employment opportunities for single parents and carers (who are more likely to be able to access working patterns that allow them to balance competing work and home priorities) more opportunity for parents to work without the expensive outlay of childcare costs.
